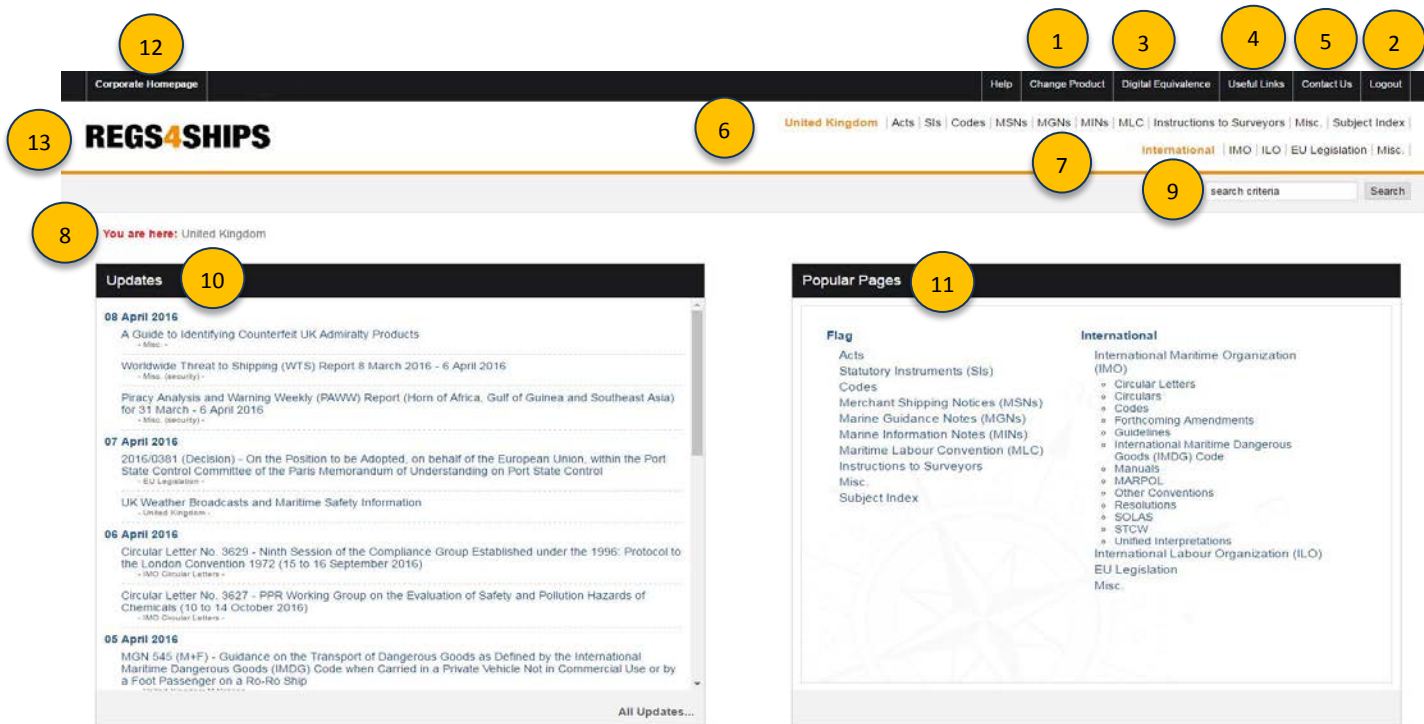

SECTION 1 - NAVIGATION

Subsection 1a - Functions and features of the Home page

Once you log onto the site and have selected your flag product you will arrive at the homepage.



- 1. Change Product** – This button allows you to change to another flag product if you subscribe to multiple products.
- 2. Log Out** – Click here to leave the product
- 3. Digital Equivalence** – Here you will find the letters of equivalence from flag states.
- 4. Useful Links** – This button provides a list of useful links
- 5. Contact Us** – This button gives you details on how to contact Regs4ships
- 6. Flag state** – This navigation bar provides you with links to your specific flag state regulatory documents (for more information see Section 3 – Flag State content).
- 7. International** – This navigation bar provides you with links to the international documents that your level of subscription gives you access to (for more information see Section 4 – International content).
- 8. You are here** – This is a series of links that tracks your position within the site. This will enable you to move backwards to previous sections by clicking on the link to the section you require.
- 9. Search** – This is the search box (for more information see the Section 2 - Search)
- 10. Updates** – This section shows the most recent updates to your subscribed products. You can click on the links to review the documents. To see more updates click on the 'All Updates' link in the bottom right corner of this panel.

11. **Popular Pages** – This section lists a series of links to help you access the most popular sections of the site including a breakdown of the IMO section.
12. **Corporate Homepage** – Clicking this link will log you out of the regulatory product and take you back to the Regs4ships log-in screen.
13. **Regs4ships logo** – Clicking on the logo will bring you back to the homepage and keep you logged in.

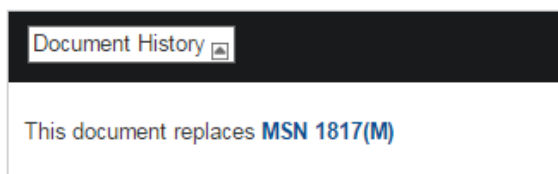
the set. If the link is 'greyed out' you are in a position where the 'greyed' options are not possible.

Document History

Throughout the site you will find Document History panels – these are used to provide information on the current status of the document. They are found just above the main content of the page and below the ‘You are here’ breadcrumb trail.



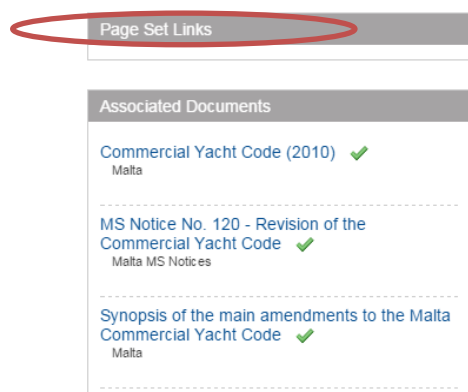
These panels often show links to amending documents or previous versions of the document or may just provide a brief history of the document.

Most international key documents are updated by amending them directly on the site – this means that we do not have to wait for consolidated versions of the documents to be published. Where a document has been amended you will find details of the amending legislation, along with links (where appropriate) in the document history panel.

Sometimes, where an amendment has been applied to the original document a contrasting colour is used so that it is easy to see where the changes have been made, this too will be documented in the document history panel.

Associated documents

Links to other relevant documents can be found in the Associated Documents panel on the left-hand side of the page below the Page Set Links. You will find the documents listed by title and below it the flag state and type of document it is.



These links may have been referred to in the main document or elsewhere on the site.

Archives

Where we have sufficient redundant documents they may be located in an archive section. You will find a link to the archive section on the main index pages under the section title.

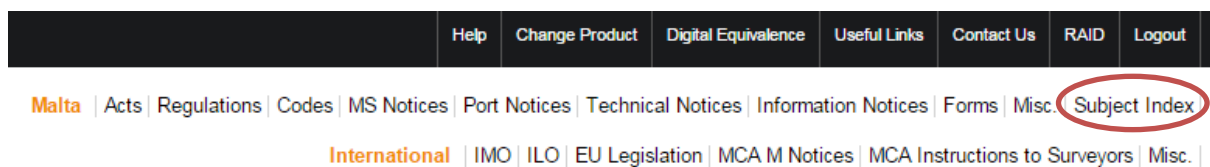

The search works in much the same way as a Google search. Below we have provided some tips to help you.

Keep it simple Use the name of the object, place or concept that you are looking for (e.g., **exhaust**, **recycling** or **hazardous materials**).

We have written a custom thesaurus which contains general spelling variations (e.g., *bouy/buoy*) and spelling mistakes (e.g., *tommorow*, *freind*, etc.) and maritime-specific synonyms and abbreviations (e.g., *CO2 / Carbon Dioxide*, *AC / Air Conditioning / Alternating Current*,).

Add relevant words If you do not get the results you want after doing a simple search try being more precise. For example:

- First try: **exhaust gas**
- More precise: **exhaust gas cleaning**
- Even more precise: **exhaust gas cleaning systems**

Use only the important words the search will ignore 'noise words' like prepositions and conjunctions (e.g., and, but, nor, so, yet, for).

Filtering Use the left-hand panel to filter your results; show results from a particular section or subject group or show/hide archived documents.

Note that punctuation can make a difference (e.g., **"masters review"** will return a different set of results than **"master's review"**).

Search for an exact phrase the search will ignore 'noise words' (*and, but, so, for*, etc.) so use quotes to search for an exact phrase (e.g., **"Collision of Ships in Restricted Visibility"**). Note that single quotes are just apostrophes, not functional characters like double quotes, and will not return the same results.

Wildcard searching Find variations of words (e.g., **man*** will find *manning, manual, management*, etc.).

Find search terms within the page Click on the icon at the end of each result link to see the matching terms within the raw indexed content.

31.14 Transfer of personnel by **gangway** 31.14.1 The master of the transfer vessel installation OIM and ERRV master must discuss the prevailing weather conditions before deciding whether it is safe enough for the transfer to proceed. Operations should only take place in the hours of daylight. 31.14.2 Transit personnel should be escorted to the **gangway** access area and must only use the **gangway** under the direction of the **gangway** operator. 31.14.3 Once on the installation transit personnel are to be escorted to the reception area. 31.14.4 The capacity of the **gangway** should not be exceeded. 31.14.5 Personnel baggage should not be carried on the **gangway**. Baggage should be transferred through the use of a separate baggage container.

When you navigate to the actual page you can use the browser's search feature to locate particular terms. In most browsers hold *Ctrl* and hit *F* to open the search dialog (*Command*/*Apple* and *F* on Macs), hitting *Enter*/*Return* will move to the next match. If it is a pdf you will need to view it in 'full page' mode to use this feature.

The type of document may vary according to the flag state that you are logged into but all flag state products contain documents that fall into the following categories:-

1. Digital Equivalence – Flag state issued documents stating that a vessel flagged to that particular state can replace some or all of their printed documents with electronic versions (CD, DVD or Internet based) and remain compliant with the carriage of nautical publication requirements.
2. Legislation -statutory law documents which have been produced by the flag state in order to regulate, to authorise, to sanction, to grant, to declare or to restrict vessels flagged to that particular state.

3. Notices – These consist of instructions, bulletins, circulars, guidance, letters or information published by the flag state.
4. Forms - We offer our product users the ease and convenience of web access for many flag state published forms.
5. Miscellaneous documents – These are documents published by the flag state which do not fall into any of the above mentioned categories – they may be additional codes or guides, manuals, handbooks, reports, memoranda or registration information.

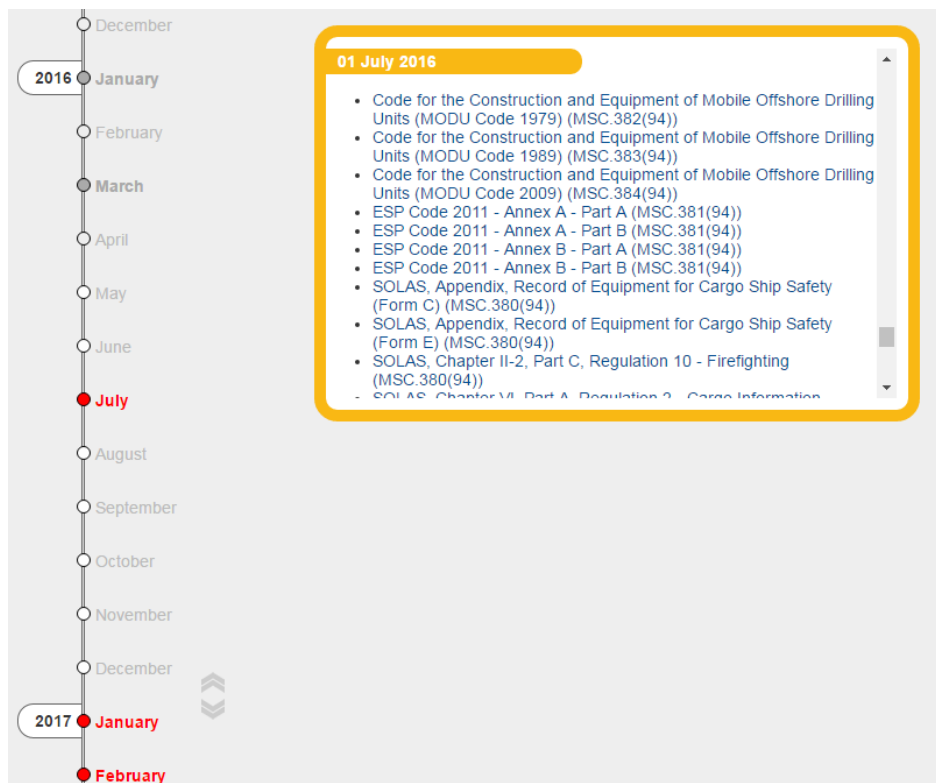

5.4.2 Ventilation systems in combination carriers

In combination carriers, cargo spaces and any enclosed spaces adjacent to cargo spaces shall be capable of being ventilated by fans. An approved fixed gas warning system capable of monitoring flammable vapours shall be provided in cargo spaces and in slop tanks. Suitable arrangements shall be made to facilitate measurement of flammable vapours in all other open deck or easily accessible positions.

5.5 Inert gas systems

5.5.1 Application

5.5.1.1 For tankers of 20,000 tonnes deadweight and upwards constructed on or after 1 July 2002 but before 1 July 2004, the inert gas system shall be in accordance with the requirements of the Fire Safety Systems Code, as adopted by resolution MSC.366(93), as described in paragraph 5.5.4.

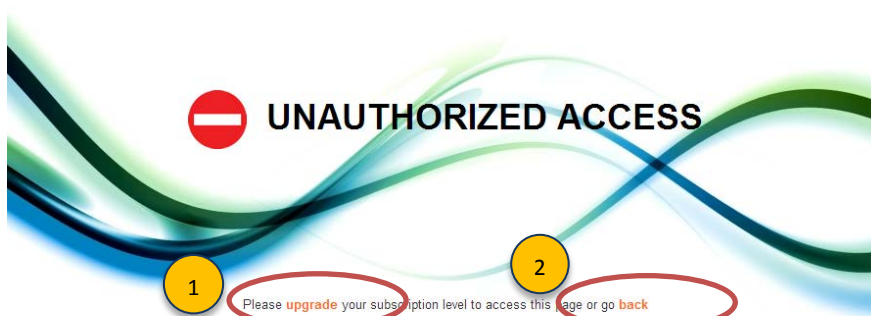

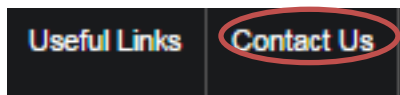
